

**ORDINANCE NO. 2013-17**

**AN ORDINANCE AMENDING THE FISCAL YEAR 2012-2013 BUDGET OF  
THE CITY OF CANTON, TEXAS; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, on September 11, 2012, the City Council of the City of Canton, Texas adopted Ordinance No. 2012-10 which adopted the official budget of the City of Canton, Texas for the fiscal year, October 1, 2012 through September 30, 2013, pursuant to procedures set forth in Chapter 102 of the Texas Local Government Code; and

**WHEREAS**, the City Council desires to implement mid-year adjustments primarily arising from additional approved and unfinished projects carried over from the previous year; and

**WHEREAS**, the City Council considers these changes to be necessary to support City operations;

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
CANTON, TEXAS:**

SECTION 1. In accordance with the provisions of Section 102.010, Texas Local Government Code, the City Council hereby amends the official budget of the City of Canton, Texas for the fiscal year, October 1, 2012 through September 30, 2013 as follows:


