Be it remembered that on the 6th day of October, A. D. 1931 came on to be held a regular session of the City Council of the City of Canton, Texas, when the following members were present and voting.

J. R. Kellis, Mayor-- Aldermen: Wl L. Steed, G. H. Hilliard, H. F. Blackwell, Jr.,

On this day came on to be considered the Tax Levy for the year 1931 to-wit:

For the purpose of paying the interest on the series of water works bonds there shall be levied and collected the sum of 50¢ on the one hundred (\$100.00) dollars valuation of all property assessed in the said City of Canton, and the same is hereby levied and assesses.

For the purpose of paying the interest on the series of Electric Light bonds there shall be levied and assessed the sum of 25¢ on the one hundred (\$100.00) dollars valuation on all property assessed in the City of Canton, Texas, and the same is hereby levied.

And for the purpose of paying the interest and creating a sinking fund for Special City improvements warrants issued by the City of Canton, there shall be levied and assessed the sum of 15¢ on the one hundred (\$100.00) dollars valuation of all property assessed in the City of Canton, Texas, and the same is hereby levied.

And for the purpose of creating a sinking fund to pay off the series of Water Works and Electric Light bonds there shall be levied and collected 25¢ on the one hundred (\$100.00) dollars valuation of all property assessed in the City of Canton, Texas, and the same is hereby levied and assessed.

And for the purpose of general revenue and general expenses there shall be levied and collected the sum of 10¢ on the one hundred (\$100.00) dollar valuation of all property assessed in the City of Canton, Texas, and the same is hereby levied and assessed.

AN ORDINANCE TO BE ENTITLED TO REGULATE THE LOCATION OF PUBLIC DANCE HALLS AND PUBLIC ROLLER SKATING RINKS IN THE CITY OF CANTON, VAN ZANDT COUNTY, TEXAS.

6-11-35

BE IT ORDAINED by the city of Canton, at special called session on April 8th, 1935; that it shall be unlawful for any person, firm, corporation or association to operate, manager, or conduct and maintain a public dance hall or a public roller skating rink within the 500 feet of any church, schoolhouse or private residence situated within the city limits of the City of Canton.

Whoever violates any provision of this ordinance shall be fined not less than five nor more than one hundred dollars.

That all ordinance and parts of ordinances in conflict herewith are hereby repealed.

AN ORDINANCE REGULATING THE PRACTICE AND TAXING OF
PEDDLERS, AND VENDORS OF GOODS, WARES AND MERCHANDISE
ON THE STREETS, SIDE WALKS AND VACANT LOTS IN THE CITY
OF CANTON, VAN ZANDT COUNTY, TEXAS

BE IT ORDAINED by the City Council of the City of
Canton, Van Zandt County, Texas; That any person or
persons or association of persons or corporations shall
be allowed to sell and offer for sale on the Streets,
Side Walks and Vacant lots in the corporate limits of
the City of Canton, Van Zandt County, Texas, hamburgers,
cold drinks, food and to operate a lunch stands or cold
drink stands, to auction and/or sell goods, wares and
merchandise at auction sale and to sell apples, bannans
and other fruits, and to sell fish or other merchandise
not auctioned, by paying the fees hereinafter shown for
each day the sell or operate; except that any church or
community may sell lunches without paying the fee, where
the proceeds go for the benefit of a church or community
activity.

Hamburgers, cold drinks and lunch stands,
fish and any merchandise not auctioned \$2.50 per day.

Auctioneers selling goods, wares and
merchandise at auction sale \$10.00 per day.

Apple, bananas and other fruit peddlers 5.00 per day.

Whoever shall violate any provision of this ordinance
shall be fined not less than one dollar nor more than
One Hundred Dollars.

That all ordinances and parts of ordinances in
conflict herewith are hereby repealed.
