Motion was made by J. H. Windham, Seconded by Curtis Hilliard, that the City pay for water Line pipe bought from Mr. Sides and used at Bryant Sanders place.

Council passed an order to call an City Election to be held the First Tuesday in April 1946, for the purpose to elect City Officials for the ensuing year.

Motion was made and seconded and carried to send Oscar Roseman to Meter School in Fort Worth for one week and pay his necessary expense in attending said school.

Motion was made and seconded that Mayor Ross be allowed to pay for reenforcement iron borrowed from City at  $\frac{3}{4}$  regular price of new iron, the Council preferred to sell reather than replacement of the iron.

Motion was made and seconded that Council hire Mr. Brown as night watchman at \$100.00 per month providing that arrangement with merchants and County can be made for greater part of the expense.
