

May we take this method of requesting you to present to the City Council at their next meeting the following.

We are in need of additional hose to equipt the old truck. The hose that is now on this truck is part of the original hose with the exception of about 200 ft. which was purchased when Pat Walker was Fire Chief and Mr. Z. W. Moore, Mayor. We only need the minimum amount that will pass the inspection of the Fire Insurance Commission.

We would like for the city council to set their policy as to the operation of the Fire Department. As you know in the past we have made small purchases for the Department, such as gas, oil, wash and grease jobs, repairs, expense for the maintanance of equipment, etc., and have had the bill sent to the city. Shall we continue to do this or do they desire us to follow another system? Please bear in mind that this is for miscelaneous purchases, not large amounts such as the hose mentioned in the first paragraph,


There has been several mention the fact about taking the old truck and making a tank truck out of it for the purpose of fighting grass fires. As Chief of the Department, we would appreciate this not being done until we find out the effect that it will have on the fire rate within the town.

In the past we have assisted in extinguishing fires in the rural area. Shall we continue to do this with the permission of the Council?

In general we would like for the Council to make any suggestion they desire as to our department and set the policy under which they desire to function, bearing in mind that it is a public service given by each and every member on the department.
