**Reduced Water Rates
For City Officials**

Reduced water rates for city officers and employees are unlawful, write the League's Legal Advisors.

The city is authorized to regulate the rates to be charged for water. Articles 1119-1123, R.C.S. However, such rates must be equal and uniform and there may not be any discrimination or inequality of rates among patrons or consumers. 34 Texas Jurisprudence 719, Section 417. Article 372, Penal Code of Texas, expressly provides that no mayor or any other member of the city council shall accept directly or indirectly any frank, privilege, free light or water, or other service, or a lower rate therefor than the regular rate established by the city council.

**Telephone Company Parking Lots
In Residential Zones**

In the opinion of the League's Legal Advisors, telephone company parking lots may not be constructed in areas zoned for residential purposes, unless the lots are located by or near a central office building already in such an area.
