IT BEING DECIDED TO PAY THE USUAL \$125.00 TO THE CANTON FIREMENS PENSION FUND.





CUNNINGHAM, & BILLY JACK PEACE OF THE FIRE DEPT, MET WITH THE COUNCIL DISCUSSING THE PROBABILITY OF PURCHASING A FIRE TRUCK TO FIGHT FIRES WITH IN ORDER TO SAVE THE NEW FIRE TRUCK, BUT NO ACTION WAS REACHED ALONG THIS LINE, BUT A MEETING FOR NEXT TUES, NIGHT FEB 21ST FOR A FURTHER DISCUSSION OF SAME.

IT WAS DECIDED TO PAY \$4.00 FOR ANNUAL DUES FOR FRENCHIE STEGALL AND TRUMAN EASLEY IN THE WATER AND SEWER ASSOCIATION,

IT BEING FURTHER DECIDED TO FIX SEWER LINE AT ARNETT ROBINSON ~~ROAD~~.

MOTION CARRIED.


