The Canton City Council met in a regularly scheduled meeting with Mayor Henry Lewis presiding. The following members were present: Ben Brown, Sam Hilliard, Gary Hatfield, Raymond Pruitt and Howard Dunn.

The minutes from the previous meeting were read and approved.

The Financial Statement was approved as submitted.

The bids submitted for the City's surplus equipment were opened and discussed. Sam Hilliard made the motion to sell two G I trucks for \$267.60 and a 1961 Ford pickup for \$112.60 to Red Hill Wrecking. Motion was seconded by Howard Dunn. All in favor.

Mr. Dean Fountain, property owner on Old Kaufman Road, met with the Council and asked them to consider the fifty foot street. There was much discussion regarding trees on this property.

Mr. Hilliard made the motion to take easement up to within twelve inches of the nearest tree in return for Mr. Fountain to release the curb and guttering. This was in agreement with Mr. Fountain. Motion seconded by Howard Dunn. All in favor.

Mr. Bill Stefka, State Board of Insurance, presented the Firemen's Pension Fund program as set out in Senate Bill 411, Section 15. There was much discussion. Gerald Turner and Raymond Pruitt will study the presentation and report their findings at the next Council meeting on the Volunteer Pension Plan.

Jimmy Jordan of Jordan Ambulance met with the Council to find out their feeling on ambulance service for the Canton, Wills Point, Edgewood area. Mr. Lloyd Groves spoke on behalf of the City in reference as to whether Mr. Jordan screened his employees who work this area.

Mayor Lewis appointed Sam Hilliard to meet with the Commissioners Court to determine their letter regarding the \$5,000.00 and Gerald Turner to contact Wills Point and Edgewood regarding why they accepted the \$5,000.00 from the County.

Motion was made by Howard Dunn to table discussion until Mr. Hilliard could meet with the Commissioners Court. Seconded by Ben Brown. All in favor.

Mayor Lewis asked Mr. Jordan to leave the second ambulance in the County until February 1. Mr. Jordan indicated he would have to let the City know whether this was possible or not.

Mr. Alvin Blackstone, resident of Canton, met with the Council regarding speeding traffic on Athens, College and Goshen Streets. Ben Brown made the motion to place four way stop signs at each of the above streets. Seconded by Gary Hatfield. All in favor.

Mike Chitty, Attorney from Terrell, Texas, representing the Canton Rural Water System, asked the Council whether it would be possible for the City to supply water to the Canton Rural Water System for the Willow Springs area. This would be an increase of 50-60%. Mr. Hilliard indicated he thought the filtering system would take care of this extra amount of water and he would have no objection.

Gerald Turner is to contact Mr. Chitty prior to February 1 regarding the Council's decision.

Mr. Tom Parsons of Texas Power & Light made a presentation on the proposed rate increase of 18.4%.

Mr. Hilliard made the motion to delay one hundred twenty (120) days. Motion seconded by Raymond Pruitt. All in favor.

Mr. Hilliard indicated his feelings as to participation in the Texas Municipal League regarding the increase in the rate presented by Texas Power & Light.

Howard Dunn made the motion to have the following serve as officials for the City election on April 1 with Foy Riley serving as judge. Seconded by Raymond Pruitt. All in favor.

Lloyd Groves, Carlye Mae Wallace, Eunice Travis, Foy Riley

Motion was made by Sam Hilliard to set the deadline for tax exemption over 65 years as July 1. Seconded by Gary Hatfield. All in favor.

Mayor Lewis asked Gerald Turner to study the request from Lois Myers regarding selling jewelry door to door. Mrs. Myers has been notified that the matter was tabled.

Gerald Turner read a certificate which was presented to Lloyd Groves, Volunteer Fireman.

The Council adjourned into Executive Session.

No action was taken in Executive Session.

The Canton City Council met in an emergency called meeting to discuss the Ambulance Service and Firemen's Pension Fund. The following members were present: Ben Brown, Sam Hilliard, Raymond Pruitt and Howard Dunn. Gary Hatfield was absent.

The City Council agreed to authorize Mr. Sam Hilliard to present an offer to Mr. John Teague of Grand Saline Ambulance Service for Mr. Teague to provide temporary emergency ambulance service to the Canton area under these conditions:

1. That \$25 will be paid to Mr. Teague for each emergency call where the patient is carried to a hospital for emergency treatment if the call was received by Mr. Truman Knox, any peace officer or the City of Canton.
2. The Canton area will include the City of Canton, the Canton School District, or any Canton rural route.
3. This agreement will not change the status of Jordan Ambulance Service subscribers.

The City Secretary was instructed to contact each Rest Home and explain the above to each Rest Home Administrator. Also, the Secretary is to advise all peace officers of this agreement.

The Firemen's Pension Plan was discussed. The City Council agreed to place the necessary funds into a savings account (provided that the Volunteer Fire Department contribute \$2,000.00 per year) to fund the Firemen's Pension Plan. The interest received from \$22,000.00 plus the \$2,000.00 per year from the Volunteer Fire Department and \$170.00 per year from the State will provide the required funds through the year 1987.

The City Council met in a regularly scheduled meeting with Mayor Henry Lewis presiding. The following members were present: Ben Brown, Sam Hilliard, Gary Hatfield, Raymond Pruitt and Howard Dunn.

The minutes from the previous meeting were read and approved with the following correction:

A study is to be made of the filtering system to determine its production before an answer can be given to the Canton Rural Water System.

Raymond Pruitt made the motion to write a letter to Judge Ray requesting the \$5,000 for ambulance service. Motion seconded by Ben Brown. All in favor.

Raymond Pruitt indicated that Lloyd Groves did not want to serve as an official for the City election on April 1. Motion made and seconded to delete Mr. Groves as an official. All in favor.

Motion was made by Sam Hilliard to pay dues to the East Texas Council of Government. Seconded by Raymond Pruitt. All in favor.

Judge Campbell spoke to the Council regarding number of cases pending and the approximate number of cases disposed of during the last six months.

Mayor Lewis authorized Gary Hatfield and Gerald Turner to be responsible for having another pit dug at the City Dump. Seconded by Raymond Pruitt. All in favor.

Mayor Lewis authorized Sam Hilliard and Gerald Turner to work up the specifications for a tractor with a sickle and rotary mower with a frontend loader and to secure bids on both a used and new tractor. The tractors we now have will be used as a trade-in.

Howard Dunn made the motion to secure bids on a new pickup also. The 1967 Chevrolet pickup the City now has will be used as a trade-in. Motion seconded. All in favor.

The Council approved Shell Oil Company to drill holes on the Canton Lake property. Gerald Turner will negotiate with their representative with the cost of \$50 per hole to be minimum.

Sam Hilliard was appointed to meet with the Commissioners Court as the Ambulance Service Representative.

Labor Day activities, including a street dance, will be discussed at the next Council meeting.

Chief of Police, Hoss Williams, asked the Council what their feelings were regarding parking on the square. It was decided to place a notice in the newspapers asking employees working on the square not to park on the square. Effective March 1 two hour parking will be enforced.

Mayor Lewis will write letter to Judge Ray regarding employees in the court house and ask them to please park on the County lot. He will also suggest that when summons for jury duty are mailed that they also advise these individuals who report for jury duty to also park on the County lot.

Billy Lively, representing the Little Dribblers, asked for assistance from the City to help finance this program for the boys and girls involved in the program. Raymond Pruitt made a motion to give the Little Dribblers \$1,000.00. Seconded by Howard Dunn. All in favor.

Mayor Lewis will write letter to the Canton Independent School District regarding the back board broken when being adjusted by one of the Little Dribbler coaches indicating that the City will pay one-half the replacement cost or up to \$250 if the school would pay the other half.

The Council adjourned into Executive Session.

No action was taken in Executive Session.

The Council went back into open session and Howard Dunn made the motion to grant a \$9,000.00 homestead exemption in 1978 for property taxes for persons over 65 years of age. Seconded by Gary Hatfield. All in favor.

The minutes from the previous meeting were read and approved.

The Financial Statement was approved as given.

The bid from Canton Motors for a new pickup was opened and the price quoted was \$3,694.90 with an allowance of \$200.00 for the 1967 Chevrolet pickup as a trade-in.

Howard Dunn made a motion to purchase the pickup from Canton Motors and advertise for bids on the 1967 Chevrolet pickup. Seconded by Ben Brown. All in favor.

Bids for a new tractor with a sickle and rotary mower were opened from Norman's Pontiac, Coleman Implement and Van Zandt County Ford Tractor. The bids will be studied by Gerald Turner and Henry Lewis before making a recommendation to the Council.

Billy Montgomery, Don Haley, Gerald Capps and Billy Rawdon met with the Council in behalf of the Canton Youth Association. Howard Dunn made the motion to give the CYRA \$6,000.00 with payments being made in April, June and August. Seconded by Ben Brown. All in favor.

Howard Dunn made the motion to pass a City Ordinance banning trucks over 10,000 pounds gross weight on residential streets. Trucks used for delivery to a residence will be excluded. Seconded by Raymond Pruitt. All in favor.

Jim Fuller met with the Council requesting permission for a Blue Grass Festival to be held on the First Monday Grounds August 18, 19 & 20, 1978. He indicated this was a family type function.

Mayor Lewis authorized Gerald Turner and Raymond Pruitt to work out the arrangements regarding this function and to let Mr. Fuller know by April 1 if it will be permissible to hold this function on the First Monday Grounds.

The Animal Ordinance was tabled until the next Council meeting.

Animal vaccination was discussed. It was noted that the local veterinarian will be having one in April.

Water and sewer rates outside the City limits discussion was tabled until the next Council meeting.

Wayland Burns of Empiregas Company of Canton met with the Council requesting permission to erect an office building and additional storage tanks to be located on Highway 64 next to their storage tanks presently there. Motion was made by Raymond Pruitt to give them permission to build with connections, at their expense, on City water and sewer. Ben Brown seconded the motion. All in favor.

Gerald Turner will issue a written authorization from the City to Empiregas.

Raymond Pruitt made the motion to send Hoss Williams to a Criminal Investigation School to be held at Texas A & M on April 25, 26 & 27, 1978, with a registration fee of \$61.80 plus \$50.00 expenses to be paid by the City. Seconded by Howard Dunn. All in favor.

The Council adjourned into Executive Session.

The Council met in Open Session.



A canvass of the election was next on the Agenda. Motion was made by Sam Hilliard and seconded by Ben Brown that the results of the election be made official. The results are listed below:



The minutes from the previous meeting were read and approved.

A motion was made by Raymond Pruitt to increase the rental fee for food vendors at First Monday \$5.00 and other vendors \$2.00. This increase will become effective for the June First Monday. Howard Dunn seconded the motion. All in favor.

A motion was made by Gary Hatfield for the Council to authorize Gerald Turner and Gerald Burgess to make overnight camping facilities on the five acres across the creek on the First Monday Grounds. Howard Paul Stegall seconded the motion. All in favor.

Raymond Pruitt made a motion to accept the budget for 1978-1979 as presented. Seconded by Gary Hatfield. All in favor.

Annexation of Lake Canton was discussed and tabled until the next Council meeting.

Howard Dunn made the motion to annex the school property on Highway 243 with the school bearing the expense of field notes to bring it within the city limits. Seconded by Raymond Pruitt. All in favor.

Raymond Pruitt made a motion to appoint Gary Hatfield as Mayor Pro tem. Seconded by Howard Dunn. All in favor.

Raymond Pruitt made a motion to appoint Howard Stegall as the representative to the East Texas Council of Government. Seconded by Howard Dunn. All in favor.

Gary Hatfield made a motion that Mayor Lewis be appointed to serve as the Ambulance Service Representative. Seconded by Raymond Pruitt. All in favor.

Hoss Williams, Chief of Police, asked that the City consider a traffic light at the entrance of the school property on Highway 243 to be used for safety purposes when functions are being held on this property at night.

Howard Dunn made a motion for the Corp of Engineers to continue with the Flood Control Plan for Dry Creek. Seconded by Raymond Pruitt. All in favor.

Gary Hatfield made a motion to authorize Gerald Turner and Howard Dunn to secure a firm to audit the City records. Seconded by Howard Paul Stegall. All in favor.

Gary Hatfield discussed several streets that needed repair work. Mayor Lewis authorized Gary Hatfield and Gerald Turner to advertise for bids for street repairs on Woodland, Dodson, Cypress and Big Rock.

Raymond Pruitt indicated nine tickets were given at the new lake for fishing and six were from out of the county for over possession of crappie.

Raymond Pruitt and Gerald Turner are to meet with Game Warden John Greenlee and bring back a recommendation to the next Council meeting.

Mr. Pruitt indicated Mrs. Dillard, resident on Tower Street, had a problem with a vine growing in her yard. Gerald Turner said he would take care of this.

Meeting adjourned to Executive Session.

Employee salary increases and leasing of an office building were discussed.

Raymond Pruitt made a motion to increase the salary of Melvin Davis \$100 per month and to place him on the payroll as a permanent employee. Seconded by Howard Dunn. All in favor.

A motion was made by Howard Dunn to increase the monthly salary of George Kenney, Shirley Hudson and Linda Ham by \$75. Seconded by Howard Paul Stegall. All in favor.

Howard Dunn made a motion to increase Hoss Williams, Gene Wilhite, Bobby Pruiett, Woodrow Janes, Truman Easley and Gerald Turner's monthly salary by \$125 and all hourly personnel to receive a minimum of \$2.65 per hour. Seconded by Howard Stegall. All in favor.

A motion was made by Raymond Pruitt to relocate the Police Department from the City Office to 205 E. Tyler Street. The First National Bank will furnish the office building rent free. The only expenses to the City will be utilities. Howard Dunn seconded the motion. All in favor.


Gerald Burgess was appointed to be in charge of First Monday Operations and the City Dump.

Minutes from the previous meeting were read and approved with the following correction:

The councilmen met in open session and a motion was made by Gary Hatfield to increase electricity fees on the First Monday Grounds \$1.00 to become effective for the June First Monday. Motion seconded by Howard Stegall. All in favor.

A bid for street repair work was opened from Smith Construction Company. Gary Hatfield made the motion to accept the bid from Smith Construction Company for pea gravel at 45¢ per square yard. Howard Stegall seconded the motion. All in favor.

It was also agreed that the maximum to spend for street repair at this time would be the \$8,000.00 which was already allocated for street repair plus \$4,500.00.

Gerald Turner recommended that the City make the water available to the Willow Springs Community. Raymond Pruitt made the motion that this increase be allowed. Gary Hatfield seconded the motion. All in favor..

Raymond Pruitt made the motion to postpone the Texas Power & Light rate increase thirty days. Gary Hatfield seconded the motion. All in favor.

Gerald Burgess made the motion that the City purchase a new sewer rodder machine. Seconded by Raymond Pruitt. All in favor. Mayor Lewis authorized Gerald Turner and Howard Stegall to purchase this equipment.

The request for an exemption of fees at the City Dump was declined.

John Greenlee, Game Warden, met with the Council to discuss the Lake Canton Fishing Regulations and recommended that the City go to the State Law allowing ten bass ten inches long per person, a maximum of twenty-five catfish (channel or blue cat) per person and twenty-five crappie per person. Mr. Greenlee also recommended that there be an ordinance indicating no trot lines allowed in the lake.

Raymond Pruitt made the motion to place a \$25 fee for all out-of-county fisherman per year per vehicle effective June 1, 1978. Gary Hatfield seconded the motion. All in favor.

Hoss Williams, Chief of Police, asked approval to send letters to Texas Power & Light, the Canton Volunteer Fire Department and General Telephone Company for their assistance in the evacuation. Approval was granted.


Sam Hilliard said the City had no legal authority to turn any money over to anyone without contacting the Cemetery Association.
