The financial statement was approved as given.

Mrs. Evelyn Melton, representing the VFW, met with the Council asking for an extension on the date of removal of their present building.

Raymond Pruitt made the motion to extend the date to March 1, 1979. Howard Dunn seconded the motion. All in favor.

A request to solicit was presented to the Council from the Jesus Christ of the Latter Day Saints Church. Howard Dunn made the motion to allow soliciting by this church. Gerald Burgess seconded the motion. Two opposed - Raymond Pruitt and Howard Stegall. Mayor Protem Hatfield voted for.

Mr. Glenn Wallace made a presentation to the Council regarding insurance coverage for City vehicles. Raymond Pruitt made the motion to carry additional insurance on the 1969 and 1977 fire trucks with the additional premium being \$616. Gerald Burgess seconded the motion. All in favor.

Mr. Wylie Pennell and Mr. Tom Henderson of Lone Star Gas met with the Council requesting the rate increase of 13.66%.

Howard Dunn made a motion to request an additional thirty day delay in giving Lone Star Gas Company an answer on their request for a rate increase. Raymond Pruitt seconded the motion. All in favor.

Gerald Turner was instructed to present figures regarding the rate increase at the next meeting.

Raymond Pruitt made a motion to approve the National Surety Bonding Company as the Bonding Company presented by Lone Star Gas. Howard Dunn seconded the motion. All in favor.

Raymond Pruitt made a motion to approve payment of dues of \$137 to the East Texas Council of Government. Gerald Burgess seconded the motion. All in favor.

Gerald Burgess made a motion that the City request from Texas Parks and Wildlife that the boat ramp originally requested for Lake Canton be transferred to the City Lake Park. Howard Dunn seconded the motion. All in favor.

Howard Stegall made a motion to purchase a load of street patching material. Gerald Burgess seconded the motion. All in favor.

Howard Dunn made a motion authorizing the City to hold an Arts and Crafts Show June 16-17, 1979, on the First Monday Grounds, and also authorizing \$400 for advertising. Howard Stegall seconded the motion. All in favor.

Gerald Burgess made a motion authorizing the City Office permission to publish a monthly paper to be distributed on the First Monday Grounds regarding activities to be held on the First Monday Grounds and articles relating to vendors. Raymond Pruitt seconded the motion. All in favor.

Raymond Pruitt made a motion authorizing Gerald Turner to advertise for bids on material and labor in regards to the surface of the tennis courts. Howard Stegall seconded the motion. All in favor.

The Council also requested Gerald Turner to secure figures on enclosing the tennis courts with a ten foot fence.

Howard Dunn made a motion to purchase a new copy machine from Pitney Bowes for the City Office. Howard Stegall seconded the motion. All in favor.


Raymond Pruitt made a motion to advertise for bids to drill an 8 inch water well complete with a test hole. Howard Stegall seconded the motion. All in favor.



The Council rejected the offer from Texas Power and Light of \$10,000 to set light poles and guard lights at the new city lake.


Employee salary increases were discussed. A motion was made by Jimmy Matthews and seconded by Howard Stegall to the following salary increases. All in favor.


The Council will submit a bid of \$725 for purchase of a rescue unit for the Fire Department.


There was some discussion regarding placing a culvert on the far side of the new city lake for the benefit of fishermen. It was decided that this could not be done at this time.




Howard Stegall made a motion to elect Dr. Dan Hilliard as City Health Officer. Gary Hatfield seconded the motion. All in favor.





The Council indicated they would support them in any way they could but at this time the City was not financially able to do so.



There was some discussion regarding a low income housing program. It was decided to check with other cities regarding this program.


