January 15, 1985
City of Canton, Texas

The City Council met at 6:00 p.m. in the City Hall at a regularly scheduled meeting with Mayor Peace presiding. All members were present.

The Minutes of the December 18, 1985 meeting were read by Gerald Turner. A motion was made by Dennis Teal, seconded by Howard Stegall, to approve the minutes as read. All were in favor.

The financial statement was reviewed by Arnold Paul. A motion was made by Maxie Turner, seconded by Raymond Pruitt, to approve the December 1984 financial statement. All were in favor.

Mr. Mike Holdway, legislative aide to Senator Ted Lyon, met with the Council to discuss bills that are before the legislature at this time.

Councilman Dennis Teal ask that Mr. Holdway send the City a copy of the Bill concerning private clubs liquor licenses. Dennis Teal and Fire Chief Cecil Tawater requested that the Bill that requires fire trucks to be replaced after reaching a certain age be amended to allow small cities, under the population of 10,000, to continue using fire trucks after reaching the maximum age and be credited on fire insurance, if the truck is in good condition and can be certified.

Speed limits inside the city limits on state highways were also discussed with Mr. Holdway.

Mrs. Edith Elliott, representing the Friends of the Library, spoke to the council concerning the purchase of the Old Church of Christ building on Big Rock Street. If the building could be purchased the Friends of the Library would renovate the building to better serve the needs of the library. Financial assistance will be needed from the City and the County for the project. A meeting with the Friends of the Library, the City Council and the County Judge and County Commissioners was set for Tuesday, January 22, 1985 at 6:00 p.m. to discuss the purchase of the building.

Mr. Rayford Hutcherson, of the Canton Cablevision, met with the Council to request a rate increase of \$1.55 per month on the basic service and ask permission to drop the Nickleodeon Channel and add the Nashville Channel. Mr. Hutcherson said there has been several requests that they add the Nashville Channel.

Dennis Teal made a motion, seconded by Maxie Turner, to grant Canton Cablevision the rate increase requested and permission to drop Nickleodeon and add Nashville. The basic rate would be increased from \$8.95 to \$10.50 per month. All were in favor.

Raymond Pruitt made a motion, seconded by Howard Stegall, to enter into a contract with Frank Dumas to lay the sewer line on the east side of Highway 19 North. The contract amount will not exceed \$10,000.00. All were in favor.

The Council set the City Election for the first Saturday in April which will be April 6, 1985. Mr. Foy Riley was appointed as election judge along with Miss Carla Mae Wallace, Mr. J. W. Terry and Mr. Lanier Starnes as clerks. Raymond Pruitt motioned that the above appointments be accepted and April 6, 1985 be set as the date for the election. The motion was seconded by Dennis Teal. All were in favor.

With a motion by Maxie Turner, seconded by Dennis teal, the Council granted Vincent Higgins' request for city water outside the city limits in the Red Hill Area. All were in favor.

Ralph Stokes and Associates, of Stokes Engineering, reported their findings on the Park Grant and the Sewer Plant Project.

Mr. Stokes, at the request of the Council, had worked up a Park Grant Application which was discussed at length. If this Grant is approved it will be on a 50-50 cost share basis.

Mr. Stokes also discussed the sewer plant problems. The Council was asked to decide if they wanted to build a new plant north of I-20 at an estimated cost of \$1,000,000.00 or do extensive repairs to the old plant at an estimated cost of \$300,000.00. These repairs would only allow the plant to be serviceable for another 5 to 10 years at the present rate of growth. At that time a new plant would have to be built. Further studies of both the old plant and the building of a new plant will be done before the final decision is made.

Raymond Pruitt made a motion, seconded by Maxie Turner, to put summer water rates in effect during the months of July, August and September. The actual rates will be discussed at a later date. All were in favor.

The Council adjourned for 10 minutes before going into executive session

Gerald Turner was given authority to give Michelle Wilson, Martha Liddle Jim McManaway and Doyle Campbell a \$50.00 per month increase in salary.

The meeting was adjourned.

Howard Paul Stegal made a motion to appoint Gail Bethune to serve out the remaining term of Dennis Teal. Maxie Truner seconded and the choice was unanimous. Gerald Turner administered the oath of office to Gail Bethune.

Raymond Pruitt motioned to adjourn and Maxie Turner seconded. The motion carried.

The City Council met at 6:00 p.m., in the City Hall at a regularly scheduled meeting with Mayor Teal presiding. All members were present.

The Minutes of the March 19, 1985, and April 9, 1985, meetings were ready by City Secretary Gerald Turner. A motion was made by Maxie Turner, seconded by Raymond Pruitt, to approve the minutes as read. All were in favor.

The financial statement was reviewed by Raymond Pruitt. A motion was made by Howard Stegall, seconded by Ronnie Fugate, to approve the March 1985 financial statement. All were in favor.

Mayor Teal announced that the ambulance service had been approved for certification by the State.

Howard Stegall motioned that Raymond Pruitt be elected as Mayor Protem. Maxie Turner seconded the motion. All were in favor.

Mr. Robert Dau of Rauscher Pierce Refsnes, Inc., made a presentation concerning issuance of bonds in order to finance the new sewer treatment plant. He outlined steps that would be necessary to follow in order to issue bonds and explained what his firm would accomplish if hired by the City as financial advisor. Raymond Pruitt motioned that Mr. Day be retained as the financial advisor. Maxie Turner seconded the motion and all were in favor. Mr. Day and Gerald Turner were to meet and discuss the sewer plant matter at a later time.

Ralph Stokes, of Stokes & Associates, Inc., went over the plans for the new sewer treatment plant and explained, for the benefit of the new council members, all the steps that have been taken toward the plant.

Phil Elledge, of the firm, discussed with the Council a plan that will lengthen the usage of the present landfill to 21 to 22 years. Mr Elledge indicated to the Council that a screen block between the next area in the landfill lot and the residences adjacent to the landfill would be an asset. Gerald Turner was directed to contact the Forestry Services in regard to the possibility of planting trees on the landfill.

The adjustment of rates for landfill usage was discussed by the Council. A motion to accept the proposed rates was made by Howard Stegall with Raymond Pruitt seconding. All were in favor.

The Council discussed proposed utility tap fees and it was determined that the new rates would only affect new taps, not old ones. Maxie Turner motioned to accept the utility tap fees as proposed. Howard Stegall seconded and all were in favor. The new utility tap rates will become effective May 1, 1985.

It was brought to the attention of the City Council that a bridge on West College Street is in need of repairs. Ralph Stokes advised the Council that it would be easier and cheaper to replace the present wooden structure with concrete box culverts. After discussing replacement cost, it was determined that until the bridge could be replaced, its use could be prolonged by removing the present asphalt hump on the bridge and placing load limit signs on either side of the bridge. Ralph Stokes advised the Council that the bridge might should be checked weekly.

The Council retired to executive session.

The City Council met at 6:00 p.m., in the City Hall at a regularly scheduled meeting with Mayor Teal presiding. Howard Stegall was the only member absent.

The Minutes of the April 16, 1985, meeting were read by City Secretary Gerald Turner. A motion was made by Maxie Turner, seconded by Ronnie Fugate, to approve the minutes as read. All were in favor.

The financial statement was reviewed by Raymond Pruitt. A motion was made by Maxie Turner, seconded by Raymond Pruitt, to approve the April 1985 financial statement. All were in favor.

Ralph Stokes, of Stokes & Associates, Inc., engineering firm, made a presentation to the Council and the public that was in attendance, regarding a new sewer plant to serve Canton. He explained that a parcel of land had been located that would be a feasible location for the construction of a new treatment plant. He explained in detail the steps that had been taken to bring the current sewer treatment plant up to meet State requirements. Thus far the City has met 80% of the requirements. Mr. Stokes informed the public that new pipelines could be laid to the new location, estimated the cost, and advised everyone that the old sewer lines can be diverted to the new plant.

Gary Burden, an associate with Stokes, showed slides of a plant similar to the one they recommend for Canton, and explained how the plant works.

Mr. Robert Day of Rauscher Pierce Refsnes, Inc., made a presentation concerning the regulations on municipal bonds and explained the different bonds that could be issued by the City to finance the new sewer treatment plant. He then presented a proposed resolution to the council for consideration. Maxie Turner made a motion to adopt the resolution, Raymond Pruitt seconded the motion. All were in favor.

Discussion was held by the Council concerning financing a new fire station. As the City can get a lower interest rate than the Canton Volunteer Fire Department, the City would apply for a \$75,000.00 loan and the Fire Department would pay for the station with funds raised through money making projects. Maxie Turner made a motion which was seconded by Ronnie Fugate, to pass a resolution authorizing financing for the new fire station. All were in favor.

Maxie Turner made a motion, seconded by Ronnie Fugate, to purchase three new Panasonic typewriters from George Harvey & Associates, of Tyler, for use in City Hall. All were in favor.

Raymond Pruitt made a motion, seconded by Maxie Turner, to purchase from the Texas Department of Highways two pickups and one sludge truck. All were in favor.

A motion to purchase six walkie talkie radios for use by the Ambulance Service, First Monday personnel, and City employees was made by Raymond Pruitt with Ronnie Fugate Seconding. All were in favor.

A motion to grant the Lone Star Gas Ordinance was made by Maxie Turner and seconded by Raymond Pruitt. All were in favor.

The Council retired to executive session.

After returning to open session, Raymond Pruitt made a motion to adopt pay raises for the ambulance service perscnnel as proposed. Maxie Turner seconded and all were in favor.

Raymond Pruitt made a motion with Ronnie Fugate seconding, to authorize Mayor Teal and Gerald Turner to sell abandoned portions of Kaufman and Terrell Streets with the understanding that the City is to be resolved of any resopnsibility in regards to the drainage problem on the Sumner property.

Raymond Pruitt made a motion to accept the ambulance policy as proposed. Maxie Turner seconded and all were in favor. The non-emergency calls portion of the policy was tabled at this time.

Residents inside city limits would be affected. The summer rates will be \$6.00 for the first 3,000 gallons used, \$1.15 per thousand gallons used up to 20,000 gallons. After 20,000 gallons the rate will be \$.90 per thousand gallons.

The Council retired to executive session.

After returning to open session, Howard Stegall made a motion, seconded by Raymond Pruitt to obtain public liability insurance through Wallace & Mann Insurance Agency. All were in favor.

Ronnie Fugate made a motion seconded by Maxie Turner to raise Al Campbell's First Monday salary by \$30.00 per month. All were in favor.

Mayor Teal, Dr. Hilliard and Gerald Turner were authorized to enter into an agreement with Monther Francis Hospital concerning a cost-sharing plan of purchasing ambulance equipment.

The Minutes of the June 18, 1985, meeting were read by City Secretary Gerald Turner. A motion was made by Howard Stegall, seconded by Maxie Turner, to approve the minutes as ready. All were in favor.

The financial statement was reviewed by Raymond Pruitt. A motion was made by Maxie Turner, seconded by Gail Bethune, to approve the June 1985 financial statement. All were in favor.

Henry Lewis spoke to the Council concerning the First Monday grounds. He suggested that he might put a cover over his section of the grounds for the vendors. After discussing the matter, the Council informed Mr. Lewis that they would favor the planting of trees in the area instead. The Council suggested that Mr. Lewis, his attorney, Mayor Teal and Gerald Turner meet and discuss the matter further.

Discussion was held concerning the passage of an ordinance authorizing publication of Notice of Intention to issue Certificates of Obligation. All were in favor of the passage.

Gerald Turner explained to the Council the need to consider another health insurance policy for the City employees. Dean Loven, of Blue Cross Blue Shield insurance, then made a presentation to the Council of a proposed insurance plan. Council tabled the question of changing policies for further discussion. Dean Loven was instructed to make a presentation of the insurance plan to the employees.

Glen Wallace made a presentation on the Historical Commission meeting he attended in Austin. He did not think that the Council would be interested in this at the present time.

Mr. Harvey Fountain made an offer of \$10,000 to the Council for the City property located behind his property at the City Lake. Raymond Pruitt announced that the City has been approved for a \$100,000 grant to use on parks and that the City would be using that money on the Old City Lake property. All Council members were against selling the property behind Mr. Fountain's home.

Mr. Verd Hall introduced Jerry Owens who made a presentation on behalf of the SPCA. Mr. Owens addressed the matter of dog alley. Raymond Pruitt informed Mr. Hall and Mr. Owens that the dog alley is privately owned and the City has no jurisdiction on this matter.

Mr. Owens suggested the passage of an animal ordinance. Raymond Pruitt suggested that Mr. Owens meet together with Gerald Turner and the City Attorney to possibly come up with an ordinance for this matter.

The Council tabled the garbage contract until later in the month in order to give Ralph Stokes time to come up with ideas on specifications.

The Council considered an application for a solicitation permit for David Marsh, Jr. Maxie Turner made the motion, seconded by Ronnie Fugate, that the City require 3 local city references for solicitation bids before a permit be considered. All were in favor.
