

ORDINANCE NO. 2021-7

AN ORDINANCE CANCELLING THE MAY 1, 2021 CITY OF CANTON GENERAL ELECTION; DECLARING LOU ANN EVERETT AS MAYOR AND NATHAN MOORE AND RANDON SUMNER ELECTED AS CANTON CITY COUNCIL MEMBERS FOR A TWO-YEAR TERM; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Canton City Council adopted Ordinance No. 2021-1 on January 19, 2021, ordering the May 1, 2021, City of Canton General Election to elect a mayor and two council members; and

WHEREAS, the city secretary has certified in writing there is no proposition on the ballot, that no person has made a declaration for write-in candidacy, and that each candidate on the ballot is unopposed for election to office; and

WHEREAS, The Election Code under these circumstances, authorizes the city council to cancel the election and declare the candidates elected to office;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CANTON, TEXAS:

Section 1. The City of Canton hereby cancels the election scheduled to be held on May 5, 2018 in accordance with Section 2.053(a) of the Texas Election Code.

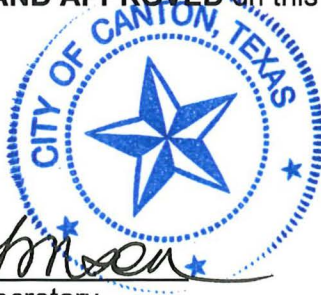
Section 2. The following candidates have been certified as unopposed and are hereby elected as follows:
